THE RECEIVER GIVES NOTICE AND DECLARES THAT:

1. On the 15th day of February, 2013, Justice Tzimas made an Order appointing Paddon + Yorke Inc., as Receiver of all of the assets, properties and undertakings of 782127 Ontario Ltd. o/a Alrange Container Service (hereinafter the "Company") pursuant to Section 243(1) of the *Bankruptcy and Insolvency Act* and Section 101 of the *Courts of Justice Act*.
2. The Receivership Order was granted pursuant to an application made by 306440 Ontario Ltd. pursuant to a General Security Agreement dated the 26th day of April, 2001.
3. The undersigned did not take possession or control of the Company's head office location at 44 Medulla Avenue, Toronto, Ontario. The Receiver did not take possession or control of the location operated by the Company.
