**NOTICE OF RECEIVER**

**THE RECEIVER GIVES NOTICE AND DECLARES THAT:**

1. On the 7<sup>th</sup> day of August 2012, Madame Justice Snowie made an Order appointing Paddon + Yorke Inc. as Receiver of all of the assets, properties and undertakings of Central Reproductions Limited (hereinafter the "Company") pursuant to Section 243(1) of the *Bankruptcy and Insolvency Act* and Section 101 of the *Courts of Justice Act*.
2. On the 7<sup>th</sup> day of August 2012 the undersigned took possession and control of the assets of the Company located at 4524 Eastgate Parkway in Mississauga, Ontario.
3. The following information relates to the appointment of the Receiver.

  - b) Principal Line of Business: Printing and Reproductions
  - c) Current Operations: Operations have ceased
  - d) Amount approximately owed by the Company to each secured creditor is as follows:

iii) Ward Spencer	\$ 95,000.58
  - e) The list of other creditors is per the attached Appendix "A".

4. The Receiver intends to :
- a. complete the two transactions entered into by the Company for the sale of it's 2005 Heidelberg Model XL105 printing press and for all of the remaining tangible assets and to collect the balance of the proceeds of these transactions pursuant to the Purchase and Sale Agreements in respect thereof entered into by the Company;
  - b. collect outstanding accounts receivable having book value of approximately \$999,370.00; and,
  - c. collect the balance due on the sale of the Toronto Maple Leafs Personal Seat License in the approximate amount of \$55,000.00.
